Rigward l-ilmenti tieghi kontra l-Psikjatra David Cassar li s'issa diga baghat 4 ittri lill-Kunsill Mediku fuq dan il-kaz, fit-3 ittra li baghat datata 18 ta' Settembru '17 mal-lista t'abbuzi li ghamel dan il-Psikjatra xtaqt inzid abbuz iehor:

18) Ghal dawn is-snin kollha zammni ostagg, mhedded u b'mazzra m'ghonqi li jekk nirrapporta l-abbuzi tieghu, jerga' jdawwarha li qed nimmagina li hemm konfossa ghaddejja kontrija, jinterpretaha li waqft niehu l-pirmlu u skuza ohra biex jerga' jaqfilni l-isptar Monte Carmeli kif ghamel fl-2002. Meta qafilni fl-2002 kienet purament show-of-force, ried jurini safejn kapaci jasal u li lilu ma jista' ghalih hadd, li jista' jikkalpestak kif u fi x'hin irid u jimmanipula l-kaz kif irid hu minghajr ma hadd jazzarda jistaqsijh jirrispondi ghall-ghemilu. Darba ttimbrani ta' mentali kien l-ewwel pass ghall-aktar abbuzi, ried jghid li bhalma qafilni fl-2002, meta jrid u fi x'hin irid jerga' jaqfilni b'aktar facilita aktar minn qatt qabel ghax issa ttimbrat mentali u allura issa bla dinjita ta' xejn ghax ma jaghtik widen hadd b'dan it-timbru. Kienet raguni ohra l-ghala fit-2 kaz tal-Qorti tal-'14 kelli nghid li ghax kont waqft niehu l-pirmlu fic-cirka 3 snin qabel l-arrest flok nghid li qatt ma kont hadt il-pirmlu tieghu f'aktar minn 12-il sena, jew nissogra li jerga' jaqfilni din id-darba ghall-ghomri l-isptar jew jaqlibni fuq l-injection kif fil-fatt ghamel. Kont imgarrab mill-esperjenza tal-2002 u kont tghallimt sew x'isarraf tirann bhalu bla kuxjenza u bla skrupli ta' xejn u sa fejn kapaci jasal.

B'xejn anqas minn 18-il abbuz wiehed aktar gravi mill-iehor, nistaqsi kemm se ddumu tagevolawh sakemm forsi xi darba taslu biex tiehdu passi kontrih.
