Regarding "Please contact the competent national authority." I have wrote the Ombudsman, the Medical Council, Commissioner for Mental Health, Police Commissioner amongst others on various issues relating to my case but it was all in vain. I was discredited as a mental to save the magistrate the career, was diagnosed as mental without any scientific evidence say brain scan etc, but simply on blatant lies with lots of contradictions, simply the stroke of a pen all that was needed. As I said Malta being so small, you end up with persons in high positions all being friends of friends, scratching each others' back. It is impossible to find a local lawyer who is ready to take it against his superior, a magistrate, as I said, and the friends of friends who cover each others up. In the website that I made, I literally did the Police job of investigation, yet the Police just do not intervene without giving me any justification. Had I written something untrue in the website, they would have for sure massacred me with libels, but because what I have written concerns people in high positions, the Police keep a step back from intervening and prosecuting those involved. I have written the EU Parliament after it was all in vain reporting to the local authorities, corruption and nepotism are simply institutionalised in Malta, both major political parties are involved in some way in it and keep the status quo. How can the EU not help, is it itself that incompetent and wants to close its eyes and cover up the local authorities rather than intervene to stop these injustices and abuses on me? Is it afraid to put pressure on the local authorities to intervene in my case and investigate the matter? Does the EU care when it concerns blatant violations of human rights on one of its citizens? Please help, you are really my last hope.
