Kif tista' tinnota fl-email tal-bierah mibghuta minn Bernard Busuttil, dan ifforwardja l-email thread t'hawn taht addirittura apposta lill-avukata Rachel Tua ghax ghidtlu u baghtlu provi li jinkriminawha, biex tispicca tivvendika ruhha minni, biex flok sibt ghajnuna spiccajt il-vittma ghal darba tnejn, mhux bizzejjed haditli €5,000 mas-sena u nofs ilu biex maqful issekwestrat innocentament kont u bqajt, flok sibt is-sapport flok ha passi fosthom kontriha u nvestigaha, qisu tifel jirrapporta lis-surmast bl-abbuzi tal-ghalliem u dan mhux talli ma jinvestigax, mhux talli ma jtihx support, talli jpattihelu hu stess jibghat lill-ghalliem x'ikun kiteb fuqu halli aktar jivvendika ruhu minnu u jpattihelu dan ukoll bit-tifel diga f'pozizzjoni zvantaggjata u abbandunat ghalih wahdu. Fuq hekk biss dan Bernard Busuttil ukoll mhux denju jokkupa l-kariga li ghandu, ahseb u ara l bil wisq aktar gravi li jonqos mid-doveri tieghu ma jinvestigax, ghax ihossu skomdu jinkrimina lill-hbieb u hbieb tal-hbieb li ghandu u miskin jien il-vittma. Li ma tiehux passi fuq abbuzi meta konxju minnhom mhux hlief cover-up of crime u jaghmllek komplici daqs minn wettaq l-abbuzi u 'n partikulari aktar gravi meta min suppost jinvestiga tali abbuzi, ma jiehu passi, ghax l-ewwel il-hbieb, il-vittma jista' jmur jindifen. Nispera li tiehu passi fuq min suppost investiga u gie jaqa' u jqum minni l-vittma ma nvestigax l-ftit mill-bizibilju t'abbuzi li ghidtlu sofrejt tul is-snin, u fuq kollox, li tinvestigaw u tiehdu passi fuq dawn l-abbuzi li sofrejt u ghadni nsufri. Forsi qbizt ftit il-limitu fil-lingwagg, imma nitlobok tifhem il-frustrazzjoni tieghi, li kull fejn inhabbat ma sibtx hlief bibien maghluqa u nies li flok jaghmlu xogholhom issibhom hbieb kollegi ma min abbuzak, ma min trid tinkrimina, u jhalluk abbandunat, u lokk ghall-aktar abbuzi.
