Kien ilni minn 27-Jan-22 li kont ktibt lill-Psikjatra Anton Grech nitlob biex naqleb taht il-Psikjatra Joseph Spiteri minflok Catherine Dimech li tlettax il-jum qabel fl-14-Jan kienet baqghet izzidli vendikattivament il-velenu tal-Olanzapine ghall-massimu possibli ta' 20mg. Ghal kwazi 6 xhur baqghu jghadduni biz-zmien u jinjoraw it-talba tieghi sakemm habta u sabta accettaw li naqleb taht Spiteri fil-21-Jun-22 apposta meta f'ismu bdejt tidher int flok Mark Xuereb. Kienet allura ferha bla temma spiccajt lanqas azzardajt insaqsihom biex inkellem lil Spiteri naf li nispicca naffacja lilek.

Ghaddejt xahrejn ohra fil-limbu meta fis-17-Aug-22 hadt ix-xokk qaluli gejtbix tkellimni. Bdejt semmejtli l-website, tipprova tintimidani ghax semmejtek fiha, u bhalma tigi li rajt il-ftit (fejn t'ohrajn) fejn hemm imsemmi int, rajt ukoll it-tant abbuzi sfaccati ohra li ilni nsufri minn ohrajn ghall-aktar minn 21 sena. Fil-fatt meta saqsejtek jekk tiggustifikax li l-Magistrat Carol Peralta kien heddidni li jsabbatni mal-hajt, ghidtili "u zgur li ghamel hazin" imma bqajt sieket meta saqsejtek taqbilx ma dak li ghamel dak il-frodist u sadist ta' kollega tieghek Psikjatra David Cassar kien dawwarhom bhala li kienu xi "psikozi ta' deluzjonijiet ta' persekuzzjoni" tieghi u bi skuza t'hekk kienu abbuзивament issekwestrannu qafaluni MW10 (u wara l-MAW fejn rajtek ghall-1 darba f'dawk is-37 b'kollox li domt innocentament maqful fl-2002, kont anki hrigtli Treatment Order hemm vilment il-firma tieghek flimkien ma ta' David Cassar). Ghidtlek biex tnaqqasli d-doza tal-pirmli imma rrifjutajt addirittura meta bi kliemek stess ikkonfermajt li kont konxju tal-abbuzi u ta' kemm kollox beda b'qerq gejtbix malizjozament ittimbrat mentali fl-isforz biex fosthom isalvaw l-karriera lill-istess Peralta, kellu jezilja ruhu jmur jahdem il-Bosnia / l-Kosovo ghal kwazi 9 snin ghax kont irrapurtajt lill-Kummissjoni Amministrattiva tal-Gustizzja, darba lura jishel ikolli t-2 kaz fl-2014 u flok irrikuza ruhu hataf l-opportunita biex ipattiheli rega hatar frodist bhal Psikjatra David Cassar vendikattiv u kriminal daqsu u aktar minnu biex aktar jghinu jilhaq l-iskop tieghu.

Insaqsik, bhala wiehed li tant thobb tkisser il-pazjenti bil-pirmli u bl-injections b'side effects tal-biza, ma tikkunsidrax sadist bhal Magistrat Carol Peralta tohroglu Treatment Order tpoggih fuq il-pirmli u njection simili ngibuha li ghandu rabja, li

mhux kapaci jikkontrolla lilu nnifsu, li ma jkunx konxju tal-gravita t'ghemilu, ecc., u daqstant iehor dak is-sadist ta' Psikjatra David Cassar, addirittura fost tant abbuzi ohra, kif jindikaw l-emails t'hawn taht mibghuta lilu u ohrajn, meta konxju li hallini maqful innocentament sekwestrat u baqa' jkissirni b'pirmli u njections anki meta ghall-ennezima darba kont infurmajtu li l-perizji huma bbazati fuq konkluzjoni zbaljata flok fetah il-kaz mill-gdid biex ma jaqghax ta' nkompetenti u ta' frodist li hu? Jien konvint li ta' Psikjatra li int, lest thalli wiehed bhali maqful innocentament u mkisser bis-side effect ta' kura velenu, milli tinkrimina lill-kollegi u l-hbieb tal-hbieb, hekk li din l-email qed nibghatilek biss bhala formalita ghax kif taf tajjeb il-kitba tibqa', ghadni maqful u nsufri abbuzi fuq abbuzi ghax nies korrotti li suppost ilhom maqfulin ghomorhom il-habs wiehed wara l-iehor ghazlu li jaghmlu l-istess (obstruction of justice, crime-laundering, cover-up of crimes, etc.).
