Huna forsi ma giex stuprat fizikament izda zgur li mentalment iva mill-psikjatra is-Sur David Cassar fuq numru konsiderevoli ta' snin b'torturi mentali u qtiegh ta' qalb ghax ghandu hafna x'jixxef, jibqa' jzommu maqful u jkissru bil-pirmlu. Darba hareg, huna rraporta lil Peralta lill-Kummissjoni Amministrazzjoni tal-Gustizzja li wara li semghet ix-xhieda referit ghall-kliem ta' Peralta ghala 'Kliem li seta' ma inghadx ghax ma kienx utli ghall-andament tal-kawza' u indirettament kixfet ix-xhieda falza tas-Sur David Cassar fuq huna (terjury) u cover-up ghar-reati ta' Peralta u li huna kien sekwestrat, maqful innocentament, meta kien inqafel Ward 10, biex jigi skreditat kieku kellu jikxef, jaghmlu l- vuci tieghu insinifikanti, ma tiswa xejn – ta' l-anqas tliet reati kriminali gravissimi minn Cassar bl-involviment ta' Peralta fuq huna.
