

Ilmenti fuq il-Psikjatra David Cassar

Rigward l-ilmenti tieghi kontra l-Psikjatra David Cassar qed nerga nikteb biex ninforma l-Kunsill Mediku bl-ahhar zviluppi.

It-Tlieta 5 ta' Dicembru '17 gie jkellimni Cassar wara li kien qata' kull kuntatt minn mieghi ghall-aktar minn sena sa mil-20 t'Ottubru '16 biex jghidli li sejjer lura minn sahhti (mentalment nifimha). Meta ghal darba tnejn ghidtlu x'ghamilt hazin biex fil-kaz nitghallem mill-izball, ma ridtx jghidli izda ghamel riferenza "ghall-ahhar li ktibt lill-Kunsill Mediku" u li "ghadhek tahseb li m'ghandikx bzonn kura". Cioe ghax irrapurtajt mill-ewwel interpretaha li qed nimmagina l-famuza konfossa u qed jikkonfermalkom dak abbuż (18) li ghal dawn is-snin kollha zammi ostagg ma nissograx nikxef l-abbużi tieghu ghax holl xaghrek u gib iz-zejt. Fil-fatt bhala riperkussjoni/vendikazzjonijiet qalli li ried izidli d-doza ta' l-injection Risperdal izda bl-iskuza biex ma jkabbarx aktar is-side effects li diga ghandi qalli li se jaqlibni fuq injection ohra Zypadhera/Olanzapine (nispera li titlobuh kjarifika fuq dan: ghaliex wasal ghal dan il-pass wara fuq sena abbandunat ma jaranix u propju f'dawn il-jiem). Kif jghidu fuq tlieta toqghod il-borma ghax ma rnexxielux ikissirni daqs kemm xtaq bl-injections Fluvoxal u Risperdal, issa se jipprova b'din b'side effects ohra xejn sbieh (ara attachment parti mill-leaflet taghha) fosthom li wara li tihodha trid taghmel 3 sieghat imwahhal jippruvawlek il-perssjoni ghax appuntu taf tghollilek il-perssjoni (immagina l-effetti aktar fuq il-menti li ghalihom hi ntenzjonata). Issa li dan l-abbuż gdid kien per konsegwenza tal-Kunsill, qed inzomkom responsabbli ghal kwalunkwe deterioramenti ohra li jista' jkolli f'sahhti. Meta ddeskrivejtu bhala tirann m'ghamiltx dan f'sahna tal-mument imma kont naf x'qed nghid tant kemm jien imgarrab – dan kollu qed jikkonfermalkom kemm hu bniedem bla skrupli li jasal ghal kollox akkost li jrid jillupjani u joqtolni biex ma nikxifx l-abbużi tieghu. Se nkun rekord assolut li fi 3 snin u nofs doqt 3 tipi t'injections, il-veru guinea pig, u li mill-esperjenza tieghi stess, sakemm jghaddu dawk ix-xahrejn sakemm jidrahom il-gisem ikunu vera martirju: tiflel il-vuci, muscle stiffness u ugigh f'partijiet ta' gismi bhal ghonqi u dahri fost l-ohrajn apparti s-side effects li jibqghu mieghek.

Biex sar jaf bl-ittri li ktibt lill-Kunsill Mediku ma nafx kienx rizultat ta' leak-offs bil-kuntatti li ghandu jew rizultat tal-Kunsill li talbu ghall-kjarifikazzjonijiet fuq li ktibt, u fil-kaz mhux fuq kjarifikazzjoni wahda jew wahdiet nistenna li tlabtuh minn 5 ittri u mat-22 abbuż li nizzilt. Dan hu hekk konvint li ma jista' ghalih hadd li jibqa' jabbuza bl-injections anki meta jaf li l-imgieba tieghi fit-2 kaz ma kinitx rizultat ghax waqaft niehu l-kura kif intenzjonalment zvia l-Qorti meta bbaza l-konkluzjonijiet tal-perizja fuq dan il-fatt u kkwotatu l-media kollha. Ghal darba ohra, qed naghmel attachment tal-pirmlu Risperdal 2mg din id-darba bil-manufacturing date 2003 u 2004 li jkompli juri kemm qatt ma hadt il-pirmlu tieghu u altru ma kienx kaz ta' relapse kif allega, izda ghal Cassar hu kruċjali li din il-verita ma tohrogx ghax tinkixiflu l-maskra u l-gideb li ilhu jghid fuqi – nispera li titolbuh kjarifika fuq din ukoll.

Rigward l-ewwel kaz xtaqt insemmi wkoll li ghas-seduta tat-12/6/02 meta Cassar qafilni l-isptar Monte Carmeli bl-iskuza li ma ridtx niehu l-pirmlu, kont minghajr avukat ghax dan kien abbandunani f'nofs kawza ftit jiem biss qabel wara li jien kont insistejt mieghu li ghandhom jittiehdu passi fuq l-abbużi li kienu qed isehhu mieghi, fosthom li l-Magistrat Peralta heddidni li jsabbatni mal-hajt fil-4/2/02, jew inkella jkun qed jiddefendi lil ta' kontrija bi flusi stess. Jekk tfittxu fil-kaz ghandhom issibu l-ittra ta' l-avukat qed jirrinunzja milli jkompli jkun l-avukat tieghi (kull avukat se jhossu skomdu jiehu passi kontra magistrat, qisu Pulizija jrid jihodha kontra l-Kummissarju). Peress li kont bla avukat, ippruvajt niddefendi lili nnifsi, imma lanqas ilhaqt ftaht halqi li Peralta ma wahhalnix multa disprezz lejn il-Qorti (ma nafx kinitx effettiva jew biss ta' intimidazzjoni ghax huti qaluli li ma kienu hallsu xejn). Peralta kompli billi hatarli avukat t'ghajnuna legali u semma isem Tonio Azzopardi li ma kienx fuq il-lista li suppost semma. Fil-fatt jekk tfittxu fil-kawza ssibu li minflok kien hemm imnizzel Martin Fenech. Huti, darba semma lil Azzopardi, marru kelmu lilu sakemm kont maqful u fil-fatt il-kawza kompliet bih. Dan ma kien avukat t'ghajnuna legali xejn ghax meta kont nghidlu x'ghandi ntih qatt ma ddejjaq jhodli l-flus. Meta ghidtlu biex niehdu passi fuq dawk l-abbużi li saru mieghi qalli li hu m'ghandux x'jaqsam ma dak li sar qabel biex tara kemm Peralta ma kienx ghazlu b'kumbinazzjoni. Kollox mahdum bizzilla kelli fl-ewwel kaz u mbaghad jigi Cassar idawwarhom f'deluzjonijiet ta' persekuzzjoni tieghi. Fit-tieni kaz ma kontx naf lil min se nqabbad avukat u ghidt lill-Pulizija biex iqabdduli lil dan Martin Fenech, dak li Peralta suppost semma minn fuq il-lista fl-ewwel kaz fit-12/6/02. Meta ghidtlu biex insemmu li l-Pulizija fl-ebda hin ma nvestigaw it-3 qtates li kelli d-dar ghal xi forma ta' maltrattament, etc. u li dan kien jikkontradixxi l-akkuzi, qalli li "dawk ghax l-annimali tieghek, thobbom" biex tara xi tfisser ikollok il-kaz ipregudikat u tkun ikkundannat mill-bidu nett bhala qattiel tal-annimali u bit-timbru ta' mentali qabel biss tellghuni ghall-ewwel seduta l-Qorti. Dawn li gejjin huma whud mill-pregudizzji mohluqa mill-Pulizija, fosthom bis-sahha tat-timbru ta' mentali li attribwili Cassar mill-ewwel kaz, li dehru fil-media:

Nerga nġhadli nzur l-ghexiren ta' links kollha gideb illum ukoll hu diffiċli ghalija ahseb u ara dak iz-zmien sakemm inqata' l-kaz u niskanta bija nniġsi llum kif kien irnexxili nibqa' haj. Niftakar f'okkazzjoni minnhom tant kont ghaddejt lejli shih nibki li filghodu kont sbaht mahnuq. U wara li nkun ghaddejt minn dan kollu Cassar itini njections li jqabduk dipressjoni, b'wahda minnhom anki ggeghlek taghmel suwucidju, u donnu ghadu ma xebax jesperimenta ghax ghal min hu bla skrupli l-vera m'hemmx limiti. Issa li tafu b'dan kollu intom ukoll komplici mieghu jekk tibqghu ma tiehdux passi fuq kaz gravissimu bhal dan: ahtru magistrat biex jinvestiga jekk intom limitati x'passi tistghu tiehdu u fejn tistghu tinvestigaw, u jekk ghar minn hekk ghandkomm kunflitt t'interest ghax uhud mill-membri pubblikament jiddikjaraw li huma hbieb ta' Cassar jew tal-mara tieghu li wkoll hi membru tal-Kunsill. Cassar suppost li ilhu li qed il-habs waqt li jien qed ninzamm innocentament ghat-3 darba, l-ewwel fit-2002, wara fit-2005 u issa mill-2014, fi sptar mentali tort tal-gideb u d-diceriji ta' Cassar u mkisser bis-side effects tal-injections li ordnali.
