Il-bierah lil huna Nicholas Grech (ID No:435076M) haduh l-ufficju tal-Psikjatra Joseph Spiteri fejn bhas-soltu b'daqqa ta' pinna u frodament qallu li hu marid u dan kollu ffit minuti biss wara li lil huna gabuh 'fit' biex jivvota, kif fil-fatt ghamel, biex tara x'kontradizzjoni dik, xi haga tipika fil-psikjatrija. Qallu li kienet ghadha kif kellmitu c-CEO S. Xuereb fuq l-emails li kiteb gimghat qabel lilha u lill-awtoritajiet dwar frodi min-naha tal-Psikjatra Joseph Spiteri, fosthom lill-pazjenti japplikalhom ghall-beneficcji socjali galor xi 4 cekkijiet fuq xi €700 fix-xahar u lil huna minkejja turrin ta' mard mentali li vvintawlu b'daqqa ta' pinna frodament, ma jiehux 1c beneficcji. Mhux b'kumbinazzjoni, xi gurnata jew tnejn minn dawn l-emails u ffit gimghat qabel l-elezzjoni, huna jircievi ittra minn tal-beneficcji socjali li se johorgulu forma ta' beneficcju.

Il-Psikjatra Joseph Spiteri, b'vendikazzjoni talli huna kien irrpurtah li hu frodist, qatghalu l-ffit permessi li kellu (Main Garden, Occupational Therapy, Social Centre) u hariglu l-eneezima restriction of freedom of communication order (rofoco) bil-barka tal-Kummissarju ghas-sahha Mentali, Denis Vella Baldacchino li bhas-soltu jservi ta' rubber stamp ghal dak kollu li jiddettawlu l-Psikjatri. Dan eku ghal dak li gara meta huna snin ilu kien irraporta lic-CEO S. Xuereb fosthom li l-Psikjatra David Cassar waqt li jkun qed suppost xoghol fl-isptar Monte Carmeli, jkun qed jithallas minn banda ohra, fejn l-istess kien pattielu hariglu rofoco. Bhas-soltu fil-Psikjatrija mhux min jabbuza hazin, imma min jazzarda jirraporta l-abbuz.

Fl-istess laqgha l-bierah mal-Psikjatra Joseph Spiteri, huna qallu biex johroglu 4 cekkijiet beneficcji u aktar kif ghamel ma pazjenti ohra, bil-Psikjatra Joseph Spiteri jghidlu: "Ghidli li inti marid u nohrogomlok!" Din kontradizzjoni ohra min-naha tal-Psikjatra Joseph Spiteri ghax jekk huna hu marid skont ma vvintalu, kif qed jistenna l-kelma ta' huna jekk hux marid jew le biex japplikalu ghall-beneficcji socjali? Huna talbu jiktiblu bil-miktub fejn minflok il-Psikjatra Joseph Spiteri, rega' rrepeta l-istess frazi. Dan kollu fil-prezenza tal-NOs ta MW1, Sandro Cortis u Nicholas Farrugia. Darba lura fis-sala, huna talab biex ikellem lill-pulizija, dwar din il-frazi ta' J. Spiteri kif kien hemm dawn ix-xhieda, li fosthom tikkonferma li kiteb huna, il-mod kif dan J. Spiteri johrog il-beneficcji socjali. Gabulu pulizija tal-isptar Monte Carmeli l kien ghasa dakinhar fejn farfar u qallu qabbad avukat flok ghamel xoghlu u ghamel rapport. Ghalhekk f'din l-email qed niktbu iswed fuq l-abjad dak li ntqal, dak li gara, biex iservi ta' evidenza, ghax kif tafu l-kitba tibqa' u qed nibghatuha lill istess J. Spiteri biex jekk irid jichad jew jikkonferma dan kollu bis-silenzju tieghu, affarih.

Ukoll din l-eneezima vendikazzjoni fuq huna mhix marbuta biss ma l-imsemmija emails ghax dan diga kellmu l-Psikjatra Hector Cutajar u ma kienx ha passi, anzi jiem wara hallewh johrog akkumpanjat sa l-arkivji. Hi vendikazzjoni sottili wkoll indirettament ghall-video li huwa tella' fuq You Tube u Tiktok (Fittex:Victims psychiatry malta) dwar l-ipokresija fil-qasam tas-sahha mentali u fl-immaniggjar ta' l-isptar Monte Carmeli, b'Kummissarju suppost ghas-Sahha Mentali minkejja website li huna waqqaf aktar minn 6 snin ilu b'evidenza aktar minn bizzejjed fuq abbuzi fil-qasam tas-sahha mentali, qed hemm paraventu biex ikompli jghattilhom u jkun komplici fl-abbuzi taghhom fuq il-pazjenti. Sabulu skuza tajba lil huna biex ghal darba ohra jcahduh u jzommuh maqful waqt li tkun ghaddejja l-festa tal-Madonna tal-Karmnu fl-isptar Monte Carmeli taf lejn Lulju li gej, kif ghamlulu sena ilu, tridx tmur.

Kif ga ktibna fl-ahhar email li baghatnilkom mas-sena ilu lil huna kienu nponewlu, l-istess Psikjatra J. Spiteri, rofoco ohra. Wiehed irid ikun veru sadist jaf li hemm bniedem maqful innocentament sekwestrat abbuzat u ma jitkellimx, ma jiehux passi, jekk mhux ukoll jasal ikun partecipi hu stess fl-abbuzi.

Huna kellu ragun lill-Psikjatra Joseph Spiteri jiddeskrivih bhala "prim u super frodist u korrot kif hemm imsemmi fl-emails attached li kien baghat fosthom lill-istess Ministru tas-Sahha gdid Jo-Etienne Abela, li beda bl-unuri, flok investiga l-abbuzi li semma huna Nicholas Grech fejn huna sa website shiha waqqaf ghad-dispozizzjoni tal-Ministru u ta' kulhadd accessibli 24x7 bl-evidenza kollha u b'dokumenti aktar minn bizzejjed, ghazel li għall-bazuzli u l-hbieb tal-hbieb jrendi ruhu komplici bil-cover-up of crimes tieghu ta' dawn l-abbuzi. Mhux talli ma hax passi, talli kompli tahhom ir-rih fil-poppa biex lill-huna, il-whistleblower, il-vittma per eccellenza, jkomplu jivvendikaw ruhhom minnu bil-liberta kollha ghax jafu li ma jista' hadd għalihom b'Ministru pupazz tagħhom u awtoritajiet qeghdin hemm għall-isem, bl-ennezime serje ta' restriction of freedom of communication orders ohra li hargulu sadanittant wahda f'wahda hawn attached, ippoguh Level 1 biex jipprovokawh b'Indjan għassa fuqu għaddej gurnata shiha jilghab bil-mobile u bil-lejl reqdin galor (ara kemm qed tiswa lill-pajjiz il-vendikazzjoni fuq huna bil-barka kollha tal-Ministru) waqt li huna mcahhad mid-drittijiet bazici tieghu li jista' jikkomunika u jitkellem!

Donnu l-Ministru Jo-Etienne Abela jhossu skomdu b'wiehed bhal huna jikteb u jikxef tant qerq fil-qasam tal-Psikjatrija, fosthom bil-frodi massicc wara l-intenzjoni biex jinghalaq l-isptar Monte Carmeli u l-pazjenti jintbaghtu f'homes anki jekk ghad-detriment ta' l-istess pazjenti, ghax hemm min se jpappiha tajjed bil-bicca. Bis-silenzju tieghek fid-dawl ta' tant abbuzi u korruzjoni daqstant gravi ghadhekk frisk fil-kariga ta' Ministru tas-Sahha, hu awgurju tajjed ghal min ghandu sehem minn din il-korruzjoni u jrid jippersevera fl-abbuzi b'aktar serhan il-mohh fuq il-pazjenti. Jekk xejn dawn l-abbuzi in partikulari fuq huna jkomplu jghinu biex aktar tinkixef l-ipokresija fil-qasam tal-Psikjatrija u t-tmermir tal-istituzzjonijiet qeghdin hemm biex jghattu xtur u l-abbuzi ta' xuxlin. Daqstant dan l-email qed tintbaghat lill-Pulizija 'n generali biex aktar ikunu konxji milli diga huma ta' xi jsarraf il-Kummissarju taghom Angelo Gafa.
