

The fraudster of Psychiatrist Joseph Spiteri



It happened that some time in year 2024, a patient who had spent time in prison ended in the same Male Ward 1 with me. Seeing me almost always with some book or a pen in hand, he confided with me whether it was good decision he chose to have them label him the mental to avoid spending almost the rest of his life in prison, seeing he otherwise still had many pending court cases, let alone the legal fees they would all incur. I told him he will end probably prescribed some poison of injection say every fortnight so that when he appears in front of that typical fake of tribunal, magistrate or judge, they will be more "favourable" to his demands.

Having gained his trust, on another day asked him about an [article on Simon Mercieca's blog](#) mentioning that Psychiatrist Joseph Spiteri was sacked from the role of Psychiatrist of the prison because inmates ended paying him big money to get them boarded out. The following is the transcript of the conversation translated to English:

Me: *Is it true what that Simon Mercieca has written that (Psychiatrist Joseph) Spiteri was sacked from the role of Psychiatrist of the prison because inmates ended paying him big money to get them boarded out?*

Patient: *Yes and they still do, Spiteri is some head of here (namely of Mount Carmel Hospital).*

Me: *No Spiteri is the vice Chairman. Above him is Anton Grech as Chairman. And you know how much they used to give him?*

Patient: *Some €5,000.*

Possibly this patient had given a sum of money to Psychiatrist Joseph Spiteri, who possibly together with the help of other fraudsters of Psychiatrists submitted the usual fake court report to the Court (*perizja*) to have him declared mental, with this patient in the meantime even

used to have some court sittings where he mentioned "*kien hemm Spiteri (jixhed) / there was Spiteri (testifying)*". The next step would probably be for this patient to pay Spiteri more "*big money*" to have him boarded out and enjoy liberty, living as a prince, a life with money from Social Benefits to spend, enjoy and feast on, at taxpayers' expense.

If [Silvio Grixti ended charged](#) (but rest assured most probably will be just a farce, will not spend one day in jail) for fraudulently entitling many to Social Benefits to buy votes for his typical corrupt of Socialist party / Government to remain comfortably in power, Psychiatrist Joseph Spiteri commits perjury, gives false testimony, submits fake reports possibly with other Psychiatrists in our mafia of Court, to have criminals labeled with mental illnesses with the stroke of a pen without any scientific evidence, to get them out of or to avoid ending in prison. And by even taking that extra step using once again his since ever fake profession of Psychiatry to fraudulently make them entitled to Social Benefits, Psychiatrist Joseph Spiteri, a criminal and fraudster himself, lets himself to be bribed by such criminals and even provides the the means (Social Benefits) to end compensated for the "*big money*"

they had to pay for his fraudulent services in the first place, everything at taxpayers' expense. So at the end of the day it's a win win situation (forgetting for a moment that venom of injection they might possibly be prescribed).

The following is the transcript of the conversation as originally said in Maltese:

Jien: Veru dak li kiteb Simon Mercieca li (l-Psikjatra Joseph) Spiteri kienu nehhewh minn Psikjatra tal-habs ghax il-habsin kienu qed ituh somma tajba biex jghaddihom board?

Pazjent: Iwa u ghadhom. Spiteri hu xi l-Kap t'hawn.

Jien: Le Spiteri hu l-Vici Chairman. Fuqu hemm Anton Grech Chairman. U taf kemm kienu jtuh?

Pazjent: Xi €5,000.

An example of a patient who passed the 2 steps with flying colours is a certain DL. From the Government portal of [eCourts](#), he has listed on his name no less than 21 Court cases, namely: [08/01/2020 ([69/2014](#)), 05/08/2015 ([413/2013](#)), 06/03/2014 ([277/2012](#)), 19/02/2014 ([351/2007](#)), 04/12/2013 ([45/2006](#)), 27/09/2013 ([27/2010](#)), 05/02/2013 ([1337/2011](#)), 27/11/2012 ([208/2012](#)), 05/10/2012 ([1105/2008](#)), 26/06/2012 ([104/2004](#)), 26/06/2012 ([1051/2008](#)), 02/12/2011 ([715/2011](#)), 28/10/2011 ([851/2010](#)), 25/05/2011 ([97/2011](#)), 02/06/2010 ([22/2010](#)), 13/04/2010 ([55/2008](#)), 20/12/2007 ([1336/2006](#)), 01/06/2006 ([528/2006](#)), 23/02/2006 ([703/2005](#)), 20/10/2005 ([249/2005](#)), 29/03/2005 ([378/2005](#))]. Those 5 marked in bold, namely those in which he was sentenced as from December 2013 onwards, saw the intervention of Psychiatrist Joseph Spiteri who, as is always the case in Psychiatry, with that simple stroke of a pen and without any scientific evidence, had this DL fraudulently labeled in this case as suffering from “*Borderline personality disorder*” ([277/2012](#), [45/2006](#)), to save him the day, and avoid him from ending sentenced again and again to prison for more and more years, to instead be transferred to Mount Carmel Hospital.

Thanks to Psychiatrist Joseph Spiteri and the systematic fraud behind his profession of Psychiatry, DL from that fraudster criminal without scruples, morphed into a mental deserving pity (from prosecuting against those court cases he still had pending, to excused with “mental insanity” for his neverending future crimes) and needing help (from paying for his crimes, to getting paid with Social Benefits), living as a prince on Social Benefits, enjoying leave from Hospital, even ending fathering a child from one they said had down syndrome or some mental illness, only to abandon her later for that umpteenth one, even sometimes going to work when supposed to be unfit with which excuse he possibly gets that extra social benefit/s. In the meantime, he evolved from a career stealing and defrauding individuals and companies for which he had amongst others so many court cases opened against him, to stealing and defrauding patients and others, possibly on an even larger scale (in particular those committed with the vulnerable patients, imbeciles and mentally retarded), with Psychiatrist Joseph Spiteri covering him up with that fake excuse of mental insanity (saving him the day from what otherwise would have been many many other court cases), as he fraudulently had

depicted him to be, always borrowing money from one and the other, repaying some of his debt by borrowing from those others like in a sort of Ponzi scheme, and so on, and when say someone may have had enough waiting for his money back, maybe all that is necessary is some threat or obscene language from this DL. In May '24 Psychiatrist Joseph Spiteri was forced to transfer him for some 10 days from Half Way House to Male Ward 1 [for the comments he made on MEP David Casa](#), in which ward there was one of his victims, namely patient JPD from whom he had stolen some €650 with that fake promise he will speak to Psychiatrist Joseph Spiteri to get him out (could have been something he used to do with inmates while in prison, acting as their intermediary for Spiteri to board them out). Days later some patient stole from MW1 clinic the smartphone of the same JPD, possibly to sell it to this DL who at that time was on the lookout for that second hand cheap one. The day after Christmas 2024, Psychiatrist Joseph Spiteri was once again forced to transfer him to Male Ward 1 as if to appear to have taken some action against this DL, this time for having stolen some €8,000 from the credit card of some patient that fool to have trusted him even with it's pin number. He came on

me asking how much it lasted my restriction of freedom of communication order, telling him a whole 5 and a half months *“for having wrote against (Psychiatrist Joseph) Spiteri and asked them to investigate him”*. He mocked me up saying: *“and also for having wrote on me”* (see same link above).

Yet another patient whom Psychiatrist Joseph Spiteri had fraudulently labeled him the mental to save him more days locked in prison, is a certain patientX. When he was transferred to Male Ward 7 in the last month or 2 of year 2022, he exhibited an aggressive behaviour, always shouting and offending not only patients but even some of the staff themselves. On that Sat 17-Dec-22 during one of the last World Cup matches, he went on a frenzy punching another patient, RG, several times on his neck, from the back. A doctor was called, not for patient RG, but for patientX as he so much punched the former that ended bleeding from his hand, in the meantime further continued to threaten RG he will end killing him, to the point that RG for his safety asked to be transferred to another ward as in fact happened. In the meantime the staff filed an incident report but when they asked Psychiatrist Joseph Spiteri if they were to report the matter also to the Police, he similarly covered patientX up with the fake excuse of mental insanity, yet so much of insanity that from the next week he began giving him leave to go with relatives out of hospital. All this is recounted in the [email shown at the end of this document](#) sent to the CEO of Mount Carmel Hospital by 3rd parties mentioning the incident, after

which some action was taken and this patientX was transferred and locked for some 3 months in Seclusion till 8-Apr-2023, after which he was transferred to MW1 completely transformed always in that happy mood. Later on Psychiatrist Joseph Spiteri started again giving him leave, even later transferring him to Half Way House. [As from 25-Feb-24 patient RG](#), who in the meantime was discharged living in some Home, ended on the Malta Police missing persons list. Had Psychiatrist Joseph Spiteri left the staff report the matter to the Police instead of covering up patientX, he would have for sure been a person of interest, by now it's probably already too late to investigate any possible links.

In the meantime, myself who for sure never caused problems, offended, stole, defrauded, punched or threatened anyone, for simply reporting abuses and asking they be investigated, was transferred and kept locked at MW1 and issued with that umpteenth restriction of freedom of communication order (rofocos: [4](#), [5](#), [6](#), [7](#), [8](#), [9](#), [10](#), ...). When asked Psychiatrist Joseph Spiteri to also fraudulently entitle me to Social Benefits, on 6-Jun-24, at the start of six in a row rofocos ([5](#) ... [10](#)), replied back: "[Tell me you are sick and I have them \(the Social Benefits\) issued for you / Ghidli li int marid u nohrogomlok.](#)" When 3 months later on 6-Sep-24 asked him again, he came with the excuse he can't do anything as I am still seen as employed [but on sick leave](#), and gave me [this letter](#) dated same day, suggesting this time, in one complete U-turn, that first I should have my employment terminated. In the meantime his firm [continued to issue me the usual sick leave certificates](#) to send to my supposed employer. When checked the matter with those of the Social Benefits, told me instead first I should be declared as sick / unfit for work / boarded out. Now once again compare to that DL who not only every now and then is allowed to go to work, but from a past in prison as a criminal ended that

fraudulently sick to fraudulently entitle him to a whole range of Social Benefits at the same time!

Also interesting is the case of what was that super corrupt and incompetent of Deputy Police Commissioner Raymond Zammit. He, as one of those in charge of my case, played a major role in [framing me up and character assassinate me](#) to save his face in what was the most humiliating case in the entire history of the Malta Police force. At that time he was also promoted to some Prison Director as in those 99 days I spent locked in the Forensic Ward, he twice came to visit the ward. About a year later it happened that not one but both of his 2 sons, who were also Policemen, ended up being investigated due to irregularities / unethical practices ([amongst them the case that was called the Gaffarena-Zammit scandal](#), etc.). It is really a case of [like father like son](#) following in their father's footsteps / example as pure incompetents not worthy of their uniform. It seems that when there was the probability that they end expelled from the Police force, first one and then the other [were fraudulently boarded out](#) with the excuse of psychiatric illnesses and suspiciously in such a short time before the conclusions of the inquiries came out so as to automatically qualify for a life pension which would have lost it if expelled from the force. Rest assured the Medical Board in front of whom

they must have appeared weren't concerned at all they were under some venom of injection for their supposed mental insanity. And to the point that one of his sons within 4 days after he was boarded out as sick not fit to go to work, was given a job in that new Enemalta of Fredrick Azzopardi with a salary of €60,000 (the salary of 3, 4 common workers) and subsequently because the case came in public everything was cancelled. Now let us join the dots: their corrupt father Raymond Zammit had been promoted to some Prison Director, possible contacts with Psychiatrist Joseph Spiteri as Psychiatrist of prison possibly when inmates were already paying that "big money" to fraudulently end boarded out (of which that **Raymond Zammit not only didn't investigate but apparently participated in the fraudulent scheme for the benefit of his corrupt sons**), using the one complete fraudulent profession of Psychiatry to fraudulently end labeled the mentals with that usual stroke of a pen, **avoid consequences for their actions, and even become entitled to Social Benefits and / or Police pension, etc.!**
