I could not believe what I was reading when today 12-Dec-23 I saw in the news that that so big fraudster and of double standards Maltese Ombudsman Joseph Zammit McKeon has been elected to the "European Region Board of the International Ombudsman Institute (IOI)" [[Joseph Zammit McKeon elected to International Ombudsman Institute board \(timesofmalta.com\)](#)]. As indicate the emails below I am forwarding to you, written in Maltese almost 6 months ago, I had amongst others asked him as the then newly chosen Maltese Ombudsman, to investigate the abuses of a local Psychiatrist, Joseph Spiteri, of which he simply ran away without doing nothing, the usual impunity enjoyed in small Malta by persons in high positions end all becoming friends and friends of friends each scratching each other's back and covering-up the abuses of each other. In another email I had sent him on the same date, he also covered-up the abuses of the Commissioner of Health within his office, a certain Raymond Galea. I had also made him aware of my website (just google my name and surname: "nicholas grech" or "smash you against the wall" or directly: <https://www.smashyouagainsthewall.com/index.html>) in which I highlighted the multitude of violations of human rights and abuses I had to suffer over the span of more than 2 decades, in particular because of a

Quoting from your [website](#): "The role of Ombudsman institutions is to protect the people against violation of rights, abuse of powers, unfair decisions and maladministration." I assure you that this Maltese Ombudsman Joseph McKeon is the exact total opposite of this definition of "Ombudsman", yet unbelievably you opted to elect such fraudster to your board, really incredible, really unbelievable. Now that I am making you aware of his so many double standards, I hope you take the necessary immediate actions and not let your reputation be tarnished by this so great fraudster of double standards Joseph Zammit McKeon. X'tahseb kieku kellek tivestiga l-frodi massicc wara l-professjoni kompletament fazulla tal-Psikjatrija, nibdew b'wiehed mill-ewlenin fost il-frodisti ta' Psikjatri, il-Psikjatra Joseph Spiteri, b'dan l-artiklu [available](https://simonmercieca.com/2021/12/20/one-of-the-reasons-given-for-col-dallis-dismissal-was-because-he-terminated-the-job-contract-of-psychiatrist-joseph-spiteri/) online 24x7 ta' Simon Mercieca (<https://simonmercieca.com/2021/12/20/one-of-the-reasons-given-for-col-dallis-dismissal-was-because-he-terminated-the-job-contract-of-psychiatrist-joseph-spiteri/>) jizvela abbuzi li dan Spiteri kien jagħmel meta kien il-Psikjatra tal-habs, u ovvjament f'pajjiz minn dejjem korrott, il-Pulizija jibqgħulek cassi, il-politici l-gurnalisti siekta. Dan Spiteri nahseb tafu sew, tiela u niezze l-għatba tal-Qorti kieku fl-artiklu hemm l-icken nitfa ta' kelma mhux vera fuq Spiteri, kieku mhux fetahlu libelli u bil-poter li għandu u ta' tipiku Psikjatra sadist prim giddib u frodist li hu lil dan Simon Mercieca vvintalu daqstant iehor b'qerq li qed ibati minn, għandu paranoia kontrih, għandu "inappropriate beliefs," u "deluzjonijiet ta' persekuzzjoni" biex jagħmel l-akbar vendetta minnu sservi ta' skuza biex jaqflu jissekwestrah 'l bogħod mill-għajn f'Ta' Frankuni fl-isptar Monte Carmeli u jgibu bla vuci u joqtlu bil-mod il-mod b'kura tipika psikjatrika pura veleno b'side effects tal-biza bhal drug-induced parkinsonism kif għamlu mieghi. Ukoll ta' Magistrat / Imhalled li kont taf sew kif gieli tahdem il-mafia ta' Qorti hawn Malta, kif min int, il-hbieb u l-ghedewwa 'l għandek jagħmlu differenza kbira u daqstant iehor l-avukat taf issib wiehed jitolbok somma tajba jgħidlek "għax jien ma niekolx wahdi," minnha jrid jitma bicca lill-

Magistrat, l-avukat ta' kontrih u taf lill-Psikjatra li jigi appuntat biex frodamment bil-gurament quddiem il-kurcifiss imdendel wara l-istess Magistrat igib lit-tali bhala li ma kellux il-mens rea, jiskuzah ibengililu biex jghaddiha lixxa u ohrog il-ghageb dawn ukoll arahom jintitolawhom bil-beneficji tal-mard (xorta jpatuha jesperimentaw il-pirmlu u l-injections fuqhom imma huma mhux l-aqwa li bic-cekkijiet wiehed fl-iehor ghandhom biex jixtru s-sigaretti u jaghmlu l-kapricci), ghal darb' ohra valeva la pena, ghall-korruzzjoni tal-Psikjatri jaghmel tajjed it-taxxi tal-popolin, hobz il-biezel l-ghazzien kielu.

Hemm ukoll dawk li wara li ghamlu zmien bis-sentenza l-habs u taf ikollhom diversi kazijiet ohra pendentli l-Qorti, jsibu s-soltu frodist ta' Psikjatra jdawwarhom bhala mentali johroghom mill-habs igibhom fl-isptar Monte Carmeli u bil-mod il-mod jibda johroghom bil-leave u jtihom il-libertajiet u ohrog il-ghageb lil dawn ukoll jikkwalifikawhom jintitolawhom ghal diversi beneficji tal-mard biex ikollhom biex ipappuha mit-taxxi tal-popolin. Wiehed minn dawn hu certu D. Lanzon wara li jghid ghamel xi 19-il sena l-habs b'karriera jisraq u jterrorizza anzjani u hekk, bil-Psikjatra Joseph Spiteri gabu mill-habs ghall-isptar Monte Carmeli u evolva jisraq "legalment" jaghmel il-kapricci galor u ma jservuhx il-beneficji li pprovdilu Spiteri mit-taxxi tal-poplu, jdur jiffroda jiddejjien ma dak u ma l-iehor jissellef m'ghand il-pazjenti u jibqa' ma jtihom xejn jew kwazi xejn, fosthom anki ffroda pazjenti jghidilhom ituh xi Eur600 biex jirrangalhom "ma Spiteri," xi uzanza sabiha li taf tghallem kemm dam il-habs sakemm ma kienx hu stess l-middleman / intermedjarju (tuni tant u nirrangalkom mal-Psikjatra Joseph Spiteri jghaddikom board) b' wiehed mill-vittmi jkun pazjent JPD li qed maqful mieghi fl-istess sala, il-vilta hi li ghax dan JPD talab u ghamel rapport lill-Pulizija flok ghajuna minn fuq dawruha li qed jimmalafama lil Spiteri, u Lanzon mhux talli ma ressquhx fuq frodi talli bil-permessi u l-libertajiet baqa', jonqof u jixxala bl-Eur600 li seraqlu. Dan Lanzon minkejja l-karattru aggressiv tieghu ma trid xejn issibu jitghajjar bik u joffendi pazjenti (bhal dawk li jitolbuh flushom lura) u staff, dejjem jghaddiha lixxa, b'nies li jkunu ghaddejjin mill-main garden tal-isptar Monte Carmeli sikwit jarawh jahsel il-karozza ta' Spiteri, issa jekk trid tifhem ifhem, valeva la pena tridx tmur.

Iehor li dak il-frodist ta' Psikjatrika Joseph Spiteri gab l-isptar Monte Carmeli wara li kien sentenzjat il-habs u ghamel perjodu hemm hu E.Grech. Dan ukoll wiehed milli Spiteri kkwalifikah ghall-beneficji tal-mard jekk mhux ukoll ghaddih board. Fost it-tant abbuzi fuq staff u pazjenti kien hemm li 1) uza forza ta' diversi daqqiet ta' ponn, 2) fuq pazjent, 3) fl-isptar Monte Carmeli facilita pubblika facilita tas-sahha, 4) quddiem pazjenti ohra tterrorizzati b'li qed jaraw jigri fuq pazjent iehor. Mbilli sar incident report, Spiteri meta qalulu biex jiftahlu kaz kriminali l-Qorti, qallhom ghax dak mentali ma fetahlu xejn ghamillu minflok cover-up of crimes (ghax nahseb kien pappiha tajjed minn fuqu, dan sa dirett fuq il-mobile gieli cempillu lil Spiteri, u taf il-velenu ta' kura Psikjatrika li ghamluh fuq komplew gabuh hekk vjolenti) u biex Spiteri juri l-faccolizmu u l-ipokresija tieghu l-gimgha ta' wara, apparti li ma waqqaflux il-permessi johrog sal-gnien tal-isptar u hekk, anki beda japprovalu l-leave johrog mill-isptar daqshekk dan Spiteri hu kontradittorju f'kull haga li jghid jaghmel (jekk qal li ghamel hekk ghax kien mentali, aktar mhux suppost fdah barra propju f'it jiem wara). Kien wara li ntbatu serje ta' emails lic-CEO tal-isptar Monte Carmeli b'recordings joffendi lil tali staff l-imsemmi pazjent li waqqfulu ghal f'it il-permess u minn xi xhur ilu regghu bdew ituhomlu lura qisu xejn mhu xejn.

Issa jien la qatt offendejt lil hadd, la qatt ghamilt abbuzi fuq staff jew pazjenti, u minkejja l-imgieba dejjem ezemplari tieghi anki meta pprovokat imcahhad minn kollox mid-drittijiet tieghi u bl-abbuzi li ghamlu fuqi sa fosthom kissruli l-laptop (parti mit-tattika tal-Psikjatrija jippruvaw minn kollox biex jipprovokaw ikissruk psikologikament biex tort tal-frustrazzjoni u l-ingustizzji fuqek tibda tkisser u ggib ruhek hazin u sservi bhala skuza biex igibuk li int "aggressiv, agitat, etc." biex aktar ikissruk bil-pirmlu u njections, imma jien dejjem nibqgghalhom kalm / kwiet ma naqghax ghall-lixxa taghhom), lanqas access ghall-gnien tal-isptar ma tani dan il-frodist ta' Psikjatrika Joseph Spiteri, ahseb u ara l-liberta jaf li qed maqful issekwestrat b'qerq, etc. (dejjem frodist qatt mhu se jikxef frodist Psikjatra iehor ghax ikun qed jikxef kemm il-professjoni taghhom mhi professjoni xejn), b'kuntrast mal-kriminali u nies perikoluzi jiggerrew l-isptar barra bil-permessi galor u bil-beneficji daqstant iehor galor.

Dan iz-2 tfal subien tieghu hargu fula maqsuma korrotti bhal missierhom kienu nvoluti f'bicca

korruzzjoni li kienet se twassal li jitkecew mill-Korp tal-Pulizija u fosthom jitilfu l-pensjoni ta' Pulizija, allura qabel waslu li jigu ssentenzjati minn tali board raw, l-ewwel wiehed u mbaghad l-iehor, li jqabdu s-soltu frodist ta' Psikjatra biex jivvinta s-soltu gideb ta' mard mentali ineziztenti bla ebda bazi xjentifika biex jghaddihom board u t-taxxi tal-poplu jaghmlu tajjeb bhas-soltu. Issa sehel li dan missierhom apparti l-kuntatti bhala Pulizija mal-Qorti, ghal xi zmien kien inhatar direttur tal-habs, Spiteri kien il-Psikjatra tal-habs u ohrog il-ghageb ma tridx wisq li kien l-istess frodist ta' Spiteri li kien involut, jghaddi board lil tant kriminali, nghid jien se jonqos ghat-tfal ta' ras kbira bhal dan u daqstant iehor kriminal mhux kull qalb trid ohra, bhal jghidlu jien qatt m'ghidt xejn fuq ir-rapporti tant fazulli t'espert fazul li int li taghmel lill-Qorti, issa tonqosx b'rapport fazul mat-tfal tieghi ghaddiehomli board ukoll bhalma ghaddejt tant kriminali ohra.

Issa b'kuntrast jien ilni bit-timbru b'qerq ta' mentali fuq 21 sena mil-2002, inqfilit gejt issekwestrat (kidnapped) fl-isptar Monte Carmeli fl-2002, 2005, u issa mill-2014, b'daqqa ta' pinna b'qerq bhas-soltu fil-Psikjatrija bla ebda bazi xjentifika, ivvintawli kullana ta' mard mentali kronaku mill-aktar gravissimu u sever, iddrogawni b'kura tipika Psikjatrika pura velenu b'pirmli u njections b'side effects tal-biza biex ikissruni fizikament, mentalment, psikologikament, izda la dan il-frodist ta' Psikjatra Joseph Spiteri li qed tahtu bhalissa u daqstant iehor lanqas il-frodisti ta' Psikjatri ta' qablu ma qatt ghaddewni board u / jew aplikawli ghall-beneficci tal-mard, kuntrarju kif ghamlu m'ohrajn b'tant qerq. Ir-raguni hi li l-ohrajn ta' kriminali li huma ghazlu li jkunu partecipi b'ruhhom u gisimhom fil-krimini komplici fil-qerq mad-daqstant iehor ta' kriminali ta' Psikjatri ghax jaqbel lilhom u mhux se jifthu halqhom meta tant swielhom u qed ipappuha tajjeb, allura ssibhom jahdmu id fid mall-korrotti Psikjatri fil-qerq. Izda jekk kriminal qatt mhu se jikxef il-qerq ta' kriminal iehor ghax jispicaw it-2 jikxfu lil xulxin it-2 ghandhom x'jitilfu, bis-skiet u l-qerq minn taht ghandhom x'jirbhu jibqghu jpappuha, jien ghax vittma per eccellenza tal-kriminali Psikjatri, opponejt ghal dan it-timbru ta' mentali fuqi b'tant qerq mill-bidunett u sa anki rajt li nirrapporta u nigbor evidenza u addirittura nwaqqaf website (kemm tikteb ismi u kunjomi titlghalek ma tal-ewwel) b'bizibilju ta' dokumenti u evidenza biex aktar nikkonferma dan il-qerq massicc, allura bhalma l-Gvern korrott kemm hu korrott mhux se nghidu ahna johrog is-salarju ta' M.Theuma ta' job fantazma meta hu stess xehed fil-Qorti li l-job mal-Gvern kienu tahuwlu b'qerq biex ma jaghlqulu halqu, daqstant iehor il-frodisti ta' Psikjatri mhux se johorguli beneficci meta jien stess qed nikxef it-tant qerq taghhom u ghandi tant evidenza fidi dwar il-qerq kif origina t-timbru ta' mentali fuqi. Tghidlix nirreferi l-kaz lill-Kummissarju ghas-sahha mentali Denis Vella Baldacchino li jahdem id fid mal-Psikjatri fl-abbuzi fuq il-pazjenti - korrott l-imsemmi Kummissarju ghas-sahha Raymond Galea fi hdan l-ufficju tieghek, ahseb u ara dan irid kollox mill-Psikjatri kemm se jirfsilhom il-kallijiet, kemm se johrog ghonqu ghall-pazjent. Daqstant iehor tghidlix nirreferi l-kaz lill-Pulizija, dawn jekk Cikku l-poplu jaghmel xi haga jintervjenu imma jekk issemmilhom xi haga kontra "Psikjatra" jghidulek "e tabib, dak qabbad avukat imexxik hu," meta l-avukat l-ewwel ma jaghmel qabel ihabel rasu jisma' l-verzjoni tieghek hi "ha nkellem wahda lill-Psikjatra l-ewwel ha nara x'ha jghid" jew inkella l-Pulizija jippretendu certifikat biex nista' nixhed propju mill-Psikjatra li rrid ninkrimina ta' mbecillati u korrotti li huma (qisu mara msawta mir-ragel u l-Pulizija jridu l-permess tar-ragel biex ikellmuha). abbuzi, u jekk jigri hekk trid terfa' r-responsabilta meta daqstant iehor ghamiltek konxju u semmejtlek bil-website fejn tista' tfittex u ssib dokumenti f'website disponibbli 24x7 dwar il-qerq u tant abbuzi fil-kaz tieghi.
